

Business Practices

- What leadership/management/communication practices are most popular in your country?
- **Answer:** "The topic of management and supply chain is popular in my school. Young people are shifting from overly bureaucratic management approaches to simple, less complex approaches for management." - **Reply:** We stated how the US has been shifting towards having more of a positive culture and moving away from less laissez-faire leadership and more open-mindedness within workgroups with diverse teams for innovated ideas in the environment.

- What careers in global supply chain management are most popular in your country?
- **Answer**: "Warehousing sector and the autonomous sector will eventually increase demand for skilled workers." Poland is "straining" towards U.S. level of technological innovations. We believe this is where jobs will be needed, along with traditional supply chain occupations as well.
- **Reply**: We discussed the increasing consumer demand for wanting goods in the right way, time, cost, and place. Since supply chains are moving faster than ever, there will be an increase in demand for jobs in order to make sure the networks are stable. We also commented on technological advancements and how jobs will soon be reallocated to different sectors.

Leadership Skills

- Are there any leadership skills that are important for the logistics profession?
- Answer: Darnia stated how leaders are now more than ever listening to individuals in the workforce and actually working with the employees with brainstorming and recommendations. Important skills should be organization, expertise in the area, practical skills. Darnia also stated how flexibility and multitasking will be a crucial skill in employee performance.
- **Reply**: We stated how we believe leaders should have an overall grasp on all the duties that they are in charge of to have a more collective mindset in operations. Additionally, since the supply chain is about efficiency and innovation, schools will need to meet skilled worker demand and develop a new curriculum that focuses more on information system classes as well as analytical skills.

- Answer: Darina stated that technology impacts supply chain in a very positive way and she believes Poland is following this trend. She states that companies investing in this technology will help save costs for companies.
- **Reply:** Both of us stated that companies in the United States are always trying to stay current with technology especially in the supply chain sector. We explained how automation is starting to be tested out and one day there could be delivery trucks with no human driving. Chris explained the some of the barriers of this technology which is state regulations, safety, security issues.

Misconceptions


- Are there any misconceptions about your country that you can clarify?
